The national organisations, whilst they may act in the humanitarian service of their governments and whilst they may be associated with other organisations, maintain their autonomy so that they may be able at all times to act in accordance with the principles of RedR. At present there are RedR organisations in 5 countries including India. The others are located in Australia, Indonesia, Malaysia and United Kingdom.

## **MESSAGE**

#### THE MANAGEMENT COMMITTEE MEMBERS

Building capacities of and providing human resources for the humanitarian NGOs is a tough ball game. Looking back at the financial year 2022-23 it became apparent that RedR India struggled to put behind the consequences of the COVID pandemic, which had impacted it's aforesaid activities and overall programming profusely.

Changes happened in the way things were perceived and worked upon at both the governance and executive level.

After being at the helm of governance, the founding team of Board Members decided to give way for a new set of professionals, to give a newer lease of life to a strategic organisation that was trying to redefine it's space within the humanitarian landscape in a post COVID frame. The new team on Board is now represented by thinkers, pragmatists and altruists, who have been contributing to the humanitarian sector since long. The collective accumen and advice would help define the ways of working for the organisation in future.

At the program level, RedR India continued working with its longstanding partners like UNICEF at national and international level, proving human resource for operationalising DRR at district level in Maharashtra and responding to flooding in Assam. RedR India's senior deployee for Assam response, Ms. Annie George was felicitated by Cachar district administration for her sincere and systematic inputs in streamlining the processes at district level.

RedR India also reinitiated relationship with Tata Sustainability Group this year, with a promise for future.

Memorandums were signed with humanitarian agencies like Caritas, Christian Aid and CARE India while discussions held with SEEDS for exploring avenues for collaboration.

Resource crunch forced retrenchment and pay cuts, but the staff members held the fort together with usual elan. We do believe that every cloud has a silver lining.

As the strategy revision for RedR India 2.0 gets underway in the following financial year, the focus would shift towards making RedR India more relevant to the changing dynamics of humanitarian sector. This would include identifying new-age thematics for capacity building and essentially engaging members for conceptualising, designing and delivering programs.

The next year would see the organisation completing twenty years of its existence and hopefully, emerge with redefined role, responsibilities and importantly, purpose.

We take this opportunity to thank all our esteemed partners, vendors, roster members and staff members for continuing to reinforce trust upon us during the trying times.

## Technical Assistance to Five Worst Flood Affected Districts of Assam for Social Sector Recovery and Preparedness for next wave for UNICEF ICO

Five experts were deployed with the intention to reinforce the technical support system for the Deputy Commissioners, of 5 worst flood affected districts in Assam. The objectives of the deployments were –

- Strengthening systems for rapid needs assessments, particularly those related to social sectors in the event of onset of another wave of flood
- Strengthening systems for rapid assessments of damages and losses, particularly those related to social sectors
- Development of department specific recovery strategies and plans focusing on rapid resumption of services critical to children and women
- Improved coordination between social sector departments in implementation of recovery plans critical towards achieving results for children
- Improved database and frequent interactions between CSOs/NGOs and departments to effectively coordinate preparedness, response and recovery actions.

The deployment duration was for 3 months starting 22nd July 2022, with extension of one district for another month

## Multi-Sectoral Capacity Development on Risk-Informed Programming & Emergency Preparedness in Assam & Tripura

RedR India in partnership with UNICEF Assam Office, built capacities of the ICDS functionaries on Disaster Preparedness and Response. An assessment was undertaken of functionality, 0 & M processes, and effectiveness of Village Action Plans with the inclusion of WASH resilient features of Piped Water Supply Schemes with special reference to the Jal Jeevan Mission guidelines. Further, the Tripura SDMA was supported in coordinating and facilitating the development of relevant plans, proposals, and institutional mechanisms monitoring systems in order to implement the SDRF and SDMF Guidelines. The Tripura SDMA was also supported in the state-level education sector risk analysis report and framework for the sector's risk-informed programming based on the analysis with recommendations for school safety and security.



# Strengthening of GO-NGO Coordination in the District of Ratnagiri, Maharashtra for enhanced Disaster Preparedness and Strengthening Urban Risk Governance with MCGM

RedR India in partnership with UNICEF MFO initiated and systematized district-level GO-NGO Coordination in Ratnagiri District. The project also resulted in strengthening disaster preparedness at the District Administration level through the participation of local NGOs, Aapda Mitras, and key line departments. Through this project, the MCGM was provided assistance in strengthening of the CDMPs and risk governance. Also, the capacities of the Aapda Mitras were built on community-based disaster preparedness.

## Disaster Response for Project Managers and Procurement Officers for Tata Sustainability Group (TSG)

For effective coordination with the government during disaster response, two joint workshops were organised by TSG for the cadre of Project Managers and Procurement Officers. The workshops were jointly facilitated by GIDM, RedR India and TSG. RedR India facilitated desktop simulation and training session on working with disaster-affected communities and leading the team for Project Managers and session on Logistics, Supply Chain Management for Procurement Officers.

The key aim of the training course was to strengthen the capacities of partner organisations on MahaPECONet's four thematic areas with special reference to Maharashtra disaster scenarios and relevance with SPHERE handbook.

## **OUR EXPERTS SPEAK**

#### Rebuilding Ratnagiri- After the Floods of 2021

Smita Pawar, a seasoned professional and a Senior Project Coordinator deployed by RedR India, undertook a transformative journey in disaster management, leveraging her prior experience with UNICEF and various NGOs. Despite limited exposure to disaster management, she dedicated one and a half month as a deployee in Ratnagiri. During 2021, Maharashtra was severely affected by landslides and floods caused by heavy rains. The district of Ratnagiri was one of the most affected regions.



The deployment provided her invaluable insights, highlighting the intricacies of disaster management. RedR tasked her with enhancing coordination between the district government and NGOs, emphasizing disaster preparedness, response, and active NGO participation in capacity building, housing, community resilience, and employment initiatives.

Smita viewed each day in Ratnagiri as a unique learning experience. Her time was dedicated to understanding disaster management strategies, systems, and perspectives from both professional and community angles. The experience prompted a re-evaluation of her skills and an exploration of diverse approaches employed by individuals facing the crisis.

Despite challenges, Smita endeavored to include marginalized groups, such as the transgender community, in capacity-building programs. Overcoming societal exclusion, she encountered initial reluctance but persisted in fostering comprehensive disaster response efforts.

The role of coordinator and deployee brought its own set of challenges. Smita navigated diverse stakeholders—government agencies, NGOs, and local communities—balancing expectations, permissions, and protocols to ensure harmonious collaboration. Government hierarchy and communication hurdles posed additional obstacles, requiring diligent efforts to gain acceptance among locals.

Smita stressed the importance of addressing divergent perceptions between the government and private sector. Sensitization about each other's roles minimizes miscommunication and encourages cooperation. Her advice for future disaster responders includes detailed study of local systems, understanding specific regional issues, and building relationships across all government hierarchy levels.

In summary, Smita's 1.5-month deployment in Ratnagiri provided a rich disaster management experience, showcasing diverse organizational approaches aimed at a common goal: providing relief and rebuilding communities post-natural disasters.

## **OUR EXPERTS SPEAK**

#### Assam Floods 2022 - Response

Annie George, with a background in rural management, became a disaster management volunteer after the 2004 South Asian Tsunami. As CEO of BEDROC in Nagapattinam and UNDP's State Project Officer post-2018 floods, she gained diverse experience. Introduced to consultancy field through RedR, Annie emphasizes the importance of leveraging established government systems for efficient disaster response.

During her Assam deployment, working with the District Disaster Management Authority (DDMA) streamlined efforts. Annie stresses the need for a deployee to build strong relationships, possess an open mind, and do thorough site homework. She successfully engaged DDMA in community facilitation centers, showcasing the importance of aligning NGO capacities for comprehensive relief efforts. Working with the




keen and hands-on disaster management official from DDMA made her job quite easy. "It was sheer good fortune that I was sent to work in that place with him", said Annie. She helped DDMA develop a proposal for this of more than ₹1.8 Crores to expand it to about 15 resource centres. As a deployee is not posted full time on the site, an efficient exit strategy is important.


Due to the nature of the work, logistics challenges like finding a place to live and taking care of meals are a common occurrence. "There are times when you are in tears because of mosquitoes and 8 daily power cuts", joked Annie. She faced another challenge of role confusion but highlights the importance of efficient exit strategies and maintaining clear communication with RedR. She advises future deployees to focus on solutions, backed by solid knowledge, and emphasizes the collaborative and rewarding nature of disaster management work despite its challenges.


#### Inflow Pattern 2022-23 (INR 1.63Cr)
